**42 Rampside Road, Barrow-in-Furness** – Conversion of the current accommodation and addition of a single storey extension to the rear elevation in order to provide 3 No. self-contained one-bedroom units and support staff areas for supported living and provision of permeable surfaced parking area.

**98-100 Friars Lane, Barrow-in-Furness** – Change of Use from betting short (sui generis) to retail shop (class E) including installation of new external air conditioning units positioned to the rear of the building and the installation of a deliveries entrance ramp and new rear deliveries entrance door (updated description).
